



**Who are they?** The *Alcohol and other Drugs Council of Australia* (ADCA) is the peak, national, non-government organisation representing the interests of the Australian alcohol and other drugs sector, providing a national voice for people working to reduce the harm caused by alcohol and other drugs.

**What do they provide?** The ADCA website provides links to help-lines and information and fact sheets on specific drugs and alcohol and strategies to minimise harm, an online searchable DRUG database and links to other internet resources pertaining to alcohol and other drugs.

**Who are they?** The Australian Drug Foundation (ADF) is a non-government, not-for-profit organisation that provides effective drug prevention for the community. **Who are they?** The *Alcohol and Drug Information Service* (ADIS) is a 24-hour telephone information, counselling and referral service for the general public, concerned family and friends, students and health professionals. ADIS is staffed by trained professionals with experience in the alcohol and other drug field.

**What do they provide?** ADIS provides a 24-hour, toll-free telephone information, counselling and referral service, information about how to access other DASSA services, and a wide range of information pamphlets, posters and other resources.

## National Centre for Education and Training on Addiction (NCETA) http://www.nceta.flinders.edu.au/

**Who are they?** The *National Centre for Education and Training on Addiction* (NCETA) is one of three research centres funded by the Australian Government as part of the National Drug Strategy. The main aim of NCETA is to utilise workforce development principles to advance the capacity of health and human services organisations and workers to respond to alcoholand drug-related problems.

What do they provide? NCETA provides a variety of publications and resources concerning alcohol- and other drug-related issues in the context of the workplace. Particular emphasis is placed on the role of workplace culture, and its impact on behaviours such as risky drinking, and strategies to manage alcohol- and other drug-related harm in the workplace. What do they provide? The NDRI website provides information on the National Alcohol Indicators Project (NAIP), which monitors and evaluates the effectiveness of state and national alcohol policies, and the School Health and Alcohol Harm Reduction Project (SHAHRP) which aims to reduce alcohol related harm among secondary school students. What do they provide? WorkCover provides a workers rehabilitation and compensation scheme for the South Australian community and promotes workplace health and safety. The WorkCover website provides numerous safety guidelines, amongst which are Guidelines for drugs, alcohol and the workplace, which aims to assist employers to establish a workplace drug and alcohol policy and program so that issues of drug and alcohol use at work can be dealt with ethically and legally. A training kit relating to workplace health and safety can also be accessed via the WorkCover website.
