

A centre of excellence

NCETA is an internationally recognised research centre that works as a catalyst for change in the AOD field. We are nationally recognised for our work in relation to:

- AOD workforce research and development
- Effective AOD preventive health strategies
- Evidence-based treatment
- Research translation.

Our purpose

To conduct and disseminate world class research that advances knowledge, innovation, and evidence-based practice to minimise harms associated with AOD use.

We envision a world where our research **informs policy and practice, builds capacity** in the workforce, and **empowers communities** to proactively prevent and address AOD harms.

Our approach

Alignment with other strategies

This strategy and the associated work of NCETA has been developed to align with:

- Flinders University Public Health Discipline Group Strategy 2030.

Our role

NCETA works in partnership with a range of stakeholders in AOD-related fields to build the capacity of health and human services sectors, organisations and individuals to prevent and respond to AOD-related issues.

This work may include, but is not limited to, the following:

- Consulting with key stakeholders and representative bodies
- Coordinating or contributing to formal partnerships
- Providing project management and evaluation
- Conducting, commissioning or collaborating on research
- Developing and testing interventions
- Translating and disseminating research findings
- Assisting stakeholders to undertake research on AOD-related workforce development
- Educating stakeholders, the generalist workforce, and the community about AOD related issues
- Identifying, developing, and implementing effective preventive health strategies.

Our stakeholders

NCETA engages with a wide range of organisations and workers who address AOD-related issues in the government, non-government, and community-controlled sectors. These include:

- 1. Specialist AOD workforce:
 - AOD specialist workers
 - Peer workers and workers with lived-living experience
 - Indigenous AOD workers.

2. Generalist AOD workforce:

- Preventive health workforce
- Health workers (including medical practitioners, mental health professionals nurses, social workers, counsellors and psychologists)
- Welfare professionals (including social workers, youth workers and other communitybased workers)
- Volunteer workers engaged in a range of community groups (e.g. parent and family groups, church groups, counselling support groups)
- · Police and law enforcement professionals
- Education sector including teachers and other education professionals
- Governments and departments (including health, work safety and child protection)
- Workplaces, organisations and industries.
- 3. Researchers within and outside of academia
- 4. Policy makers
- 5. Media and journalists
- 6. The general public.

Our strategic priorities

Priority 1: Strengthen the evidence base to prevent AOD harms in Australia and internationally

Our research on primary and secondary prevention is important for developing evidence-based strategies that effectively reduce AOD harms. We aim to provide insights into risk factors (particularly at the population level), intervention effectiveness, and emerging trends - guiding policy and practice to improve public health outcomes.

Priority actions will include:

- Identifying, developing and evaluating effective interventions to prevent AOD harms including preventing or delaying use, reducing harmful use and ending use (particularly with tobacco)
- Working with end users to develop research agendas that will inform policy
- Working to build community knowledge of AOD harms and reduce harmful use

Priority 2: Strengthen capacity in Australia's AOD services and specialist and generalist workforces

We undertake research to strengthen Australia's AOD workforce by providing a robust and comprehensive evidence base that addresses complex substance-related questions. We recognise that the AOD workforce is not restricted to AOD specialist workers but also includes anyone who works with AOD issues as part of their role. This includes medical specialists, nurses, social workers, police, teachers, bar staff, managers and occupational health and safety officers. Our approach is evidence-based and we research a wide range of individual, organisational, structural, social and systemic factors that can impact on the ability of the workforce to effectively and efficiently respond to AOD issues.

Priority actions will include:

- Understanding key stakeholders' research needs and international gaps in evidence
- Developing and implementing a short-, medium- and long-term research strategy that is prioritised according to emerging trends and/or aligns with needs of the sector

Priority implementation activities will include:

- Providing training to specialist and generalist workforces
- Identifying and influencing the high-level systems that shape the workforce (e.g. legislation, policy, resources)
- Generating evidence to inform the development of resources/tools that support and improve worker wellbeing and individual performance (e.g. education, training, best practice guidelines)

Working to increase Flinders University's educational offerings in AOD.

Priority 3: Build strong partnerships and collaborations

We acknowledge that partnerships are vital for bringing together diverse expertise, resources, and perspectives, leading to more innovative, comprehensive and translatable findings. Collaboration enhances the reach and application of research outcomes, making them more impactful for communities, priority groups (e.g. Aboriginal and Torres Strait Islander or high prevalence groups) and policymakers.

Priority actions will include:

- Building strong partnerships and collaborations with Aboriginal and Torres Strait
 Islander groups
- Building and growing national and international research partnerships
- Building new collaborations with Flinders University teams (including Rural and Remote Health, Statewide Gambling Therapy Service, Institute for Mental Health and Wellbeing, Adelaide Institute for Sleep Health and Paramedicine)
- Strengthening partnerships with the AOD workforce including through NCETA's AOD
 workforce reference groups, Australian Injecting and Illicit Drug Users League (AIVL)
 and other representatives of the lived-living experience workforce, and AOD peaks
- Engaging with policymakers and NGOs across Australia to ensure NCETA's work is responsive to emerging policy priorities.

Priority 4: Disseminate our research

We see a core function of the centre as disseminating our research findings to reach a broader audience, maximising reach and impact, and ensuring findings are accessible to diverse audiences, including academics, practitioners, policymakers, people who use alcohol and other drugs, and the public. We aim to use varied platforms including peer-reviewed journals, conferences, social media, and community presentations tailored to different stakeholders' needs.

Priority actions will include:

- Increasing our contributions to the scientific literature by increasing our peerreviewed publications in first quartile (Q1) journals
- Sharing our work with the AOD sector through policy and practice briefs, webinars and presentations, social media, and tailored training
- Building community understanding of AOD issues by engaging with media, social media, and community presentations.

Priority 5: Build a strong sustainable team

A strong team fosters collaboration, diversity of thought, and shared expertise, which enhances the quality and impact of our research and teaching. It also provides mentorship, support, and resilience, allowing our team to be sustainable and tackle large and complex challenges.

Priority actions will include:

- · Attracting, nurturing, and retaining world class academics into NCETA
- Facilitating a culture of shared success by celebrating achievements
- Diversifying and increasing sources of research funding
- Increasing the integration of perspectives from people who identify as Aboriginal or Torres Strait Islander into NCETAs research and outputs
- Developing our early career researchers and building a strong cohort of HDR students to grow Australia's AOD research capacity.
