POSITION SUMMARY

The National Centre for Education and Training on Addiction (NCETA) is an internationally recognised Research Centre that works as a catalyst for change in the alcohol and other drugs field. The Centre works to reduce the harms from alcohol and other drugs from prevention through to treatment. NCETA is located within the College of Medicine and Public Health and is part of the Flinders Health and Medical Research Institute (FHMRI) at Flinders University in South Australia. NCETA is home to the Substance Use Research and Evaluation (SURE) Program which conducts analysis, tracking and review of substance use patterns and outcomes for the South Australian Government.

The Research Fellow will undertake a range of research, evaluation, consultancy and analysis activities to contribute to SURE deliverables under the broad direction of the Manager, SURE Program, NCETA. The Research Fellow will also be required to lead various other research projects within NCETA, including: the development and conduct of surveys; systematic reviews; the production of high-quality research proposals; and the preparation of reports and peer-reviewed publications.

The Research Fellow will actively report on new and current research related to the research program, through generation of high quality publications and conference presentations. In addition, the position will contribute to the development of applications and tenders for externally funded research.

The Research Fellow may also be required to supervise honours and post-graduate research projects and deliver guest lectures.

The Research Fellow is responsible for:

- Playing a lead role in project management including coordinating, planning and executing project tasks
 and preparing project reports and other complex documents required to successfully deliver project
 milestones and meet Key Performance Indicators, including those set by external funders.
- Independently contributing to translational research and evaluation by producing high quality, actionable written reports for funders of commissioned projects.
- Independently contributing to ethical, high quality and innovative research and evaluation through
 activities such as scholarship, publishing in recognised high quality journals and assisting the
 preparation and submission of bids for external research funding.
- Independently contributing to the planning and execution of research by offering new and innovative
 ideas, reviewing relevant literature and other sources of information, actively participating in the
 production of data, contributing to the writing and editing of grant applications and disseminating the
 Centre's research findings via conference, seminar and workshop presentations.
- Independently contributing to high quality quantitative and qualitative data collection, collation and analysis including ethics submissions.
- Undertaking comprehensive literature searches including systematic reviews of published and grey literature for funders in the form of reports and policy briefings and publication in the peer-reviewed literature.
- Developing and contributing to the development of research proposals, tenders and grant applications.
- Preparing project reports, peer-reviewed papers, and other complex documents as required.
- Supervision of research assistants and student research projects (including undergraduate, honours and post-graduate students) and undertaking guest lectures.
- Establishing and maintaining relationships with key stakeholders and funders and collaborating with academic and non-academic partners at State, national and international levels in order to improve research outputs and publications.
- Some out of hours work (including weekends) as well as rural SA, interstate and overseas travel, may be required.
- Any other responsibilities in line with the level of the position as assigned by the Supervisor and/or the University.

- 6. Demonstrated understanding of statistical methods and knowledge of SPSS or an equivalent package to undertake statistical analyses, and the ability to work with nationally representative data sets.
- 7. Demonstrated ability to critically review the literature in relevant fields.
- 8. Demonstrated scientific writing skills that demonstrate attention to detail to ensure accurate recording of research methods, summary of findings, referencing and formatting
- 9. Demonstrated project management skills to plan and organise workload including multiple projects to ensure projects are meeting internal and external deadlines.
- 10. Self-motivation and ability to work under limited supervision
- 11. Demonstrated well-developed interpersonal skills, oral and written skills in an academic environment and experience in collaborating and engaging with diverse stakeholders and industry partners.
